11	request is supported by PacifiCorp and the Industrial Customers of Northwest Utilities			
12	("ICNU"). All other parties to this docket have been contacted regarding this motion and none

14	Staff requests a second modification in the schedule because PacifiCorp, ICNU and Staff			
15	are still negotiating about the appropriate method to calculate the transition adjustment for			
16	PacifiCorp's Fall 2004 window. The negotiating process has been slowed due to the absence of			
17	a key analyst and the need for all negotiating parties to model the different proposals offered by			
18	the parties.			
19	Staff, ICNU and PacifiCorp met at a settlement conference on April 29, 2004, continued			
20	to May 6, 2004, and then to May 13, 2004. Because any agreement on the appropriate method			
21	for a transition adjustment cannot be finalized before the due date for Staff and Intervenor			
22	testimony, Staff requests the due date be extended by seven days to May 27, 2004.			
23	Staff does not request any other modification to the schedule. PacifiCorp is agreeable to			
24	allowing its due date for testimony, June 24, 2004, remain the same.
