Parties submit final closing briefs addressing all issues, including <i>Highland Cellular</i> -related issues	June 4, 2004
Applicant files papers for redesignation and maps	June 4, 2004
Parties will indicate to ALJ who will be arguing on June 10	June 7, 2004
Oral arguments before Commissioners	June 10, 2004
Applicant requests order be issued	June 30, 2004

The dates for filing are considered "in-hand" dates. OTA reserves the right to object to the lack of cross-examination on the maps to be provided by the Applicants in each docket.

For the oral arguments to be held June 10, 2004, in the Main Hearing Room, before the Commissioners, one hour will be allotted to each case. Oral arguments in UM 1083 will begin at 9:00 a.m., and arguments in UM 1084 will begin at approximately 10:00 a.m. The Applicant, OTA, and Staff each will have 20 minutes to address the Commission; Applicant will proceed first and may reserve time for rebuttal at the end; OTA will go second; and Staff will go third.
