On June 24, 2004, the Public Utility Commission of Oregon (Commission) received a joint application from PacifiCorp and Consumers Power requesting approval of allocation of service territory. A general description of the areas related to this proposal is as follows:

**Description of Consumers Service Territory
To Be Transferred
From Consumers Power, Inc.
To PacifiCorp**

The point of beginning, being approximately 1500 feet south of the North line of Section 1, T. 12 S., R. 2 W., W.M. Linn County at the intersection of the South line of Tax Lot 202 and the existing territory boundary of Consumers Power, Inc. and Pacific Power; thence East approximately 430 feet to the centerline of the Southern Pacific railroad; thence southerly along the centerline of the Southern Pacific railroad approximately 1450 feet to the South line of Tax Lot 2600; thence West approximately 400 feet to the intersection of the existing territory boundary of Consumers Power, Inc. and Pacific Power; thence northerly 326 feet parallel to the East line of Section 1, T. 12 S., R. 2W., to a point; thence East 100 feet; thence North 660 feet; thence east 100 feet; thence North approximately 440 feet to the point of beginning.

**Description of PacifiCorp Service Territory
To Be Transferred
From PacifiCorp
To Consumers Power, Inc.**

The point of beginning, being 1230 feet West of the Southeast corner of Section 22, T. 11 S., R. 5W., W.M. Benton County, Oregon and Southerly 137.15 feet along the West line of Kings Boulevard; thence southerly 175 feet more or less along the West line of Kings Boulevard to the centerline of Professional Way; thence Westerly 346.52 feet along the said centerline line of Professional Way; thence continuing 229 feet more or less along an arc along the centerline of Professional Way to a point approximately 134 feet south of the South line of Section 22, T.11

S. R. 5 W.; thence easterly and parallel to the said South line of Section 22 to the West line of Kings Boulevard and the point of beginning.

More detailed descriptions and additional information may be obtained from PacifiCorp, Consumers Power, or the Public Utility Commission of Oregon.

Any affected party or customer may request a hearing on this matter within 30 days of the second and final publication date of this notice. The final publication date is July 22, 2004; therefore, requests for hearing will be due by August 23, 2004. The Commission will, within 30 days of such request, set the time and place of a hearing. The hearing will produce the record from which the Commission will determine whether or not the territory will be allocated.
