Idaho Power hereby provides notice that it only intends to cross-examine Staff Witnesses Galbraith and Owings. Idaho Power expects that its cross-examination of Staff Witness Galbraith will take approximately 30 minutes. The cross-examination of Mr. Galbraith will be directed to Mr. Galbraith's recommendations concerning Idaho Power's test year net power supply expense.

Idaho Power's cross-examination of Staff Witness Owings would be very limited and would only be necessary to clarify issues associated with the stipulation and supporting testimony that will be filed later this week. Once the stipulation and testimony are filed, it is likely Idaho Power will be able to waive cross-examination of Ms. Owings.

Idaho Power has reached agreement with the Oregon Industrial Customers of Idaho Power ("OICIP"), under which agreement Idaho Power has agreed to forego cross-examination of OICIP Witness Reading in exchange for OICIP agreeing to forego cross-examination of Idaho Power Witnesses Kolar and Pengilly.

Idaho Power has reached a similar agreement with CUB in which Idaho Power has agreed to forego cross-examination of CUB Witnesses Jenks-Brown in exchange for CUB's agreement to waive cross-examination of Idaho Power Witnesses Pengilly and Kolar.

Idaho Power reserves the right to pursue follow-up cross-examination questions of any witness that is cross-examined by another party.
