The parties to the above-referenced consolidated dockets have agreed to the following proposed schedule:

- April 14th Edge Wireless LLC (“Edge”) provides Commission Staff (“Staff”) and the Oregon Telecommunications Association (“OTA”) with a draft second amended application covering additional issues raised by the Federal Communications Commission’s (“FCC”) new Eligible Telecommunications Carrier (“ETC”) designation rules, set forth in Order 05-46, released March 17, 2005;
- April 28th Staff and OTA provide Edge with any comments on the draft second amended application;
- May 12th Edge provides Staff and OTA with a draft stipulation, draft testimony and the final version of the second amended application;


