**MOTION TO AMEND PROCEDURAL

8 during the last two months. At the conclusion of yesterday's settlement conference, a  
9 majority of the parties in this proceeding reached, in principle, a global settlement. The  
10 parties are now engaged in drafting the Stipulation and supporting documents.

11 As a result, MEHC and PacifiCorp now seek to modify the schedule to accommodate  
12 the filing of a Stipulation and supporting documents, in lieu of the current schedule which  
13 contemplates a fully litigated resolution of the case. The current schedule is as follows:




