

1. Idaho Power is a regulated public utility in the State of Oregon. Idaho Power's service territory in the State of Oregon encompasses portions of Malheur, Harney, and Baker Counties.

2. Idaho Power and PacifiCorp jointly own the Jim Bridger Power Plant in Western Wyoming. Idaho Power maintains several transmission interconnections with PacifiCorp and is a signatory to numerous contracts with PacifiCorp.
