13 On September 26, 2006, undersigned counsel erroneously filed and served

15 The document filed and served twice was the COMPLAINANTS' RESPONSE
16 TO PGE'S AMENDED MOTION TO DISMISS, ABATE, OR MAKE MORE
17 DEFINITE AND CERTAIN. The document not filed at all was the APPLICANTS'
18 RESPONSE TO PGE AMENDED COMMENTS ON APPLICATION FOR
19 DEFERRED ACCOUNTING. During the finalization process, the latter document
