COMPANY'S MOTION TO AMEND  
SCHEDULE**

Pursuant to OAR 860-11-0000, Portland General Electric Company ("PGE") hereby moves to amend the schedules in dockets UM 1224 and 1226. In its response to PGE's Amended Motion to Dismiss, the Utility Reform Project and Ken Lewis ("URP") alluded to filing an Amended Complaint. In addition, URP did not file response comments in support of its deferred accounting application in a timely fashion. After conferring regarding these matters, URP and PGE have agreed to propose a revised schedule in dockets UM 1224 and UM 1226 that permits URP to file an Amended Complaint. The proposed revised schedule is as follows:

PGE files Reply in Support of Motion to Dismiss (if applicable)	December 21, 2006

Counsel for PGE has conferred with counsel for Commission Staff, and Staff does not object to these scheduling changes. Good cause therefore exists to amend the schedule in these dockets in the manner proposed in this motion.

For the reasons stated above, PGE respectfully requests the entry of a Scheduling Order or ruling in dockets UM 1224 and UM 1226 consistent with this motion.
