Dear Ms. Nichols:

AT&T Mobility LLC (“AT&T Mobility”)<sup>1</sup> files this letter requesting the Commission issue an errata to Order No. 07-111 entered March 29, 2007 (“Order”). The errata is necessary to correct the list of wire centers in the Order for which AT&T Mobility has ETC designation. A proposed errata with the correct list is attached to this letter as Order No. 07-111 Appendix A, Page 7 of 9, Errata (“Appendix A Errata”). Commission Staff has reviewed this letter prior to filing and supports AT&T Mobility’s request.

AT&T Mobility and Commission Staff have reviewed Appendix A and determined that a correction is necessary. Pioneer Telephone Cooperative has renamed its Chitwood wire center (CHWDOR) to Eddyville (EDVLOR). The list of wire centers appended to Order No. 07-111 refers to the old Chitwood identification. This should be amended to reflect the new name.

The specific revision is as follows:

- Delete “Chitwood and replace it with “Eddyville (EDVLOR)”.
