MOTION FOR MODIFICATION
OF RVM SCHEDULE
**[EXPEDITED CONSIDERATION
REQUESTED]**

Settlement discussions regarding the RVM portion of this consolidated docket have been held recently. Portland General Electric (“PGE”), Staff of the Public Utility Commission (“Staff”), the Citizens’ Utility Board (“CUB”) and the Industrial Customers of Northwest Utilities (“ICNU”) were the only parties that participated in the settlement discussions. An agreement in principal resolving the RVM portion of this docket has been reached between PGE, Staff, CUB and ICNU (the “Participating Parties”). The Participating Parties anticipate that a Stipulation and supporting joint explanatory brief will be filed by August 21.

Pursuant to OAR 860-013-0031, Portland General Electric (“PGE”) requests that five dates included in the current RVM portion of the schedule in this docket be stayed, and that dates be set for the filing of any objections to the Stipulation to be filed in this matter. Specifically, PGE requests that the following dates be stayed:

PGE RVM testimony:	August 21, 2006
RVM Hearing:	August 30, 2006
RVM Opening Briefs:	September 14, 2006
RVM Closing Briefs:	September 22, 2006
RVM Oral Argument:	September 26, 2006

The current schedule lists October 20, 2006 as the date for a Commission Decision regarding the RVM. A Commission decision by that date is necessary to implement the November election window under the RVM. Accordingly, PGE requests that the Administrative Law Judge set a deadline for parties to file any objections to this Stipulation, and if any objections are filed, set an expedited schedule, including a hearing if necessary, such that a Commission decision can be made by October 20, 2007.

The Participating Parties support this motion.

CONCLUSION AND EXPEDITED CONSIDERATION REQUEST

For the reasons discussed above, PGE requests that the administrative law judge issue an order postponing the RVM related dates listed above. The first deadline sought stayed is 5 days from today, therefore expedited consideration of this motion is requested. In addition, if any further proceedings are necessary, expedited scheduling may be necessary to make possible a Commission decision by October 20, 2006.
