Portland General Electric (“PGE”) hereby moves for a one week extension of the time in which it may respond to the Motion for Reconsideration of the Citizens’ Utility Board. CUB seeks reconsideration of Order 07-454, issued October 22, 2007. The Motion for Reconsideration was filed on December 18, 2007. Pursuant to OAR 860-014-0095, a party may file a reply to the motion for reconsideration within 15 days from the date the application was filed. In this case, that would mean that a reply is due on January 2, 2008. Due to work schedules including two holidays, and previously scheduled vacation time for some PGE

personnel last week and this week, PGE requests one additional week to file a response to CUB's motion.

Under OAR 860-011-0000 the Commission may deviate or waive any of the rules in Divisions 011 through 014. Further, pursuant to OAR 860-012-0035 the Administrative Law Judge has the authority to limit or extend filing periods and grant waivers. PGE has contacted CUB, Staff of the Public Utility Commission, and the Industrial Customers of Northwest Utilities, and none of those parties object to a one week extension of time to file a reply.

For the reasons discussed above, PGE requests that the Administrative Law Judge issue an order extending the deadline for filing a reply to CUB's Motion for Reconsideration to January 9, 2008. Since the current deadline is one week from today, expedited consideration of this motion is requested.
