1 3. On February 5, 2009, Idaho Power Company filed a Supplemental Application in this  
2 docket requesting that the Commission acknowledge an Addendum to its acknowledged 2006  
3 Integrated Resource Plan to include the proposed Boardman to Hemingway transmission line.

4 4. The Company operates an integrated transmission system throughout six states, including  
5 California, Idaho, Oregon, Utah, Washington and Wyoming. PacifiCorp is interconnected to  
6 Idaho Power Company for the purpose of serving retail customers and works cooperatively with  
7 Idaho Power Company on numerous transmission projects on a regional and sub-regional basis.  
8 As proposed, the Boardman-Hemingway Transmission Line will connect with other regional  
9 transmission systems in an effort to provide reliable electric service.


10 5. For these reasons, the Company has a direct and substantial interest in this proceeding.


