Notice of Transfer of Customers from X2Comm, Inc. d/b/a DC Communications (CP 1361)
to Legent Comm LLC d/b/a Long Distance Services d/b/a Long Distance America (CP 1147)
and
Cancellation of Authority of X2Comm, Inc. d/b/a DC Communications (CP 1361)

I. INTRODUCTION

X2Comm, Inc. d/b/a DC Communications (“X2Comm”) and Legent Comm LLC d/b/a Long Distance Services d/b/a Long Distance America (“Legent Comm”), collectively the Parties (“Parties”), hereby notify the Oregon Public Utility Commission (“Commission”) of a transfer of customers from X2Comm to Legent Comm. Upon the completion of the customer transfer, X2Comm will no longer operate within the state of Oregon and is requesting cancellation of its authority to provide interexchange telecommunications services within the state of Oregon.

II. THE PARTIES

X2Comm, Inc. is incorporated under the laws of the state of Nevada in 1999, with its headquarters located at 270 South Main Street, Suite C, Flemington, NJ 08822. X2Comm received authority to provide interexchange telecommunications services in the state of Oregon in CP 1361 / Order 01-1021 on April 2, 2007 and CP 991 Order 01-1021 on December 12, 2001.

Legent Comm LLC is a Nevada limited liability company formed on March 30, 2013 with its headquarters located at 10161 Park Run Dr., Suite 223, Las Vegas, NV 89145. The Company originally received authority to provide interexchange telecommunications services in the state of Oregon in CP 1147/ Cert 8117 Order 03-234 on April 21, 2003.

III. DESCRIPTION OF THE TRANSACTION

Pursuant to a Purchase Agreement (“Agreement”) between the Parties, X2Comm proposes to transfer its customer base consisting of 40 customers to Legent Comm, which will become the service provider for the resold long distance telecommunications services that the customers currently receive from X2Comm. Upon closing of the transaction, X2Comm will discontinue its intrastate resold long distance service offerings, and wishes to cancel its authority. This transfer of customers is scheduled to be completed by August 1, 2022 at which time, X2Comm wishes to cancel its authority as a provider of long distance services.

The proposed transfer of customer base will have no adverse impact on X2Comm's customers who will continue to receive the same long distance services, under the same rates, terms and conditions of service following the transfer to Legent Comm. The Parties have notified all affected customers of the proposed transfer, see the attached Customer Notice in **Exhibit A**, and have filed a Notification of the customer base transfer with the FCC pursuant to Section 64.1120(e)(1) of the FCC rules. The Parties propose to close the transaction upon receipt of all required regulatory approvals, including that of the Federal Communications Commission.

IV. PUBLIC INTEREST STATEMENT

Approval of the proposed transaction will serve the public interest. As noted above, the Transaction will have no negative impact on the customers served by X2Comm, who will continue to receive the same long-distance services at the same rates, terms and conditions. Legent Comm will notify the customers of any future changes in rates, terms and/or conditions of service consistent with applicable regulatory requirements. Based upon its experience in successfully providing resold long-distance services to retail customers in the U.S. over the past 20 years, Legent Comm is well qualified to serve the customers presently served by X2Comm.

V. WAIVER

X2Comm respectfully requests a waiver from the Anti-Slamming Rule.

VI. CONCLUSION

Based on the foregoing, X2Comm, Inc. d/b/a DC Communications and Legent Comm LLC d/b/a Long Distance Services d/b/a Long Distance America respectfully request that the Commission promptly approve this transaction and cancel X2Comm, Inc.'s authority.

NOTICE OF CHANGE IN SERVICE PROVIDER

On August 1st, 2022, Legent Comm LLC d/b/a Long Distance America d/b/a Long Distance Services ("Legent") will become your new provider of long-distance telecommunications services currently provided by X2Comm, Inc. d/b/a Direct Connect Communications ("X2 Comm") pending regulatory approval.

The transfer of the services to Legent will include a seamless transition that will not affect the current services that have been provided previously by X2 Comm.

In the event of any future changes to the services, rates, or terms and conditions, Legent will file appropriate tariff changes pursuant to state and federal rules and law, including notification to affected customers, if applicable.

You have a right to select a different preferred carrier for your long-distance telecommunication services. Legent does not anticipate that this transition will cause you to incur any carrier change charges. If you do, Legent will pay the carrier change charges associated with the transfer to Legent.

The services will be transferred to Legent, even if you have arranged preferred carrier freezes through your local service providers on the services involved in the transfer, unless you select a different carrier before the transfer date. If you have a preferred carrier freeze on your account for long distance services, it will be lifted. You must contact your local service provider if you would like to arrange new preferred carrier freezes.

Legent will be responsible for handling complaints filed, or otherwise raised, during and after the transfer relative to both X2Comm and Legent.
