MOTION TO MODIFY SCHEDULE

7 Request to Add Schedule 111, Advanced
8 Metering Infrastructure (AMI)

9 Staff of the Public Utility Commission (“staff”) asks the administrative law judge to
10 modify the remaining procedural schedule in this docket. The modification is needed to
11 accommodate a delay in PGE’s efforts to the implement the advanced metering infrastructure
12 and is supported by Portland General Electric Company (“PGE”), the Citizens’ Utility Board
13 (“CUB”), the Industrial Customers of Northwest Utilities (“ICNU”), the Oregon Department of
14 Energy, and the Community Action Directors of Oregon (“CADO”).

15 The modified schedule supported by these parties is as follows:

23 2007.


