RE: November 1, 2007 Draft MONET Runs for PGE's 2008 AUT (Docket UE 192) and Biglow Canyon (Docket UE 188)

Enclosed are PGE's November 1st Draft MONET runs in UE 192 and UE 188. They comply with the Commission's recent order in UE 192 (Order No. 07-445) and include final power and fuel contracts, as well as new gas and electric price curves, all as of October 25, 2007. The final system load forecast from PGE's October 1st update is unchanged. However, consistent with PGE Tariff Schedule 125, the enclosed MONET runs are based on cost of service loads of 2,247 MWa, rather than 2,269 MWa (per the October 1st update), reflecting 22 MWa that opted out during the September window.

Attachment 1 provides a hard copy of the Step Change Log, Summary of Changes to MONET, Assumptions Summaries both with and without Biglow Canyon, and summary MONET output for forecasts both with and without Biglow Canyon. Attachment 2 is a CD with several electronic files, including the MONET runs. The electronic files are password protected using the same password as that used for other protected files in these dockets. Attachments 1 and 2 are confidential and subject to the Protective Order issued in UE 192 (Order No. 07-135).

Updated net variable power costs (NVPC) for 2008 are \$767,836,000 before consideration of Biglow Canyon and \$744,708,000 inclusive of Biglow Canyon. Comparable figures from the PGE's initial filings earlier this year were \$776,960,000 and \$755,018,000. These November 1st MONET runs also reflect a cost of service load forecast of 2,247 MWa, which is lower than the 2,275 MWa load forecast from PGE's initial filings. The November 1st per unit power costs (both with and without Biglow Canyon) are nearly identical with comparable figures in PGE's initial filings.

UE 192 and UE 188 November 1, 2007, Draft MONET Runs November 1, 2007

Per the schedule in UE 192, PGE will provide an update to the forecasts of power costs on November 8^{th} , reflecting an updated forward curve, and PGE will file its final power cost updates on November 14^{th} , using a five-day average of forward curves over the period November 1-7.
