9	After the hearing on October 26, 2007, and in order to have a decision by the end of the	
10	suspension period, the Administrative Law Judge offered November 5 <sup>th</sup> and November 12,	
11	2007, as dates for opening and reply briefs. On October 29, 2007, the Crooked River Ranch	
12	Water Company (CRRWC) filed a motion for extension. CRRWC requests briefing dates of	
13	November 12 <sup>th</sup> for opening briefs and November 19 <sup>th</sup> for reply briefs. Staff opposes the	
14	requested extension to the extent that it requires further extension of the suspension period.	
15	The testimony of the Public Utility Commission of Oregon Staff (Staff) recommends	
16	rates that are substantially lower than existing rates. Furthermore, the existing rates are not	
17	interim rates subject to refund. As a result, it is Staff's view that an extension of time further	
18	harms members in allowing an unjust and unreasonable rate to continue past the initial	
19	suspension period.	
20	In Order No. 06-642, entered November 11, 2006, the Public Utility Commission of	
21	Oregon (Commission) ordered CRRWC to file tariffs. Because of applications for extensions	
22	that were granted to file tariffs, there will be a 12-month period from the time tariffs were	
23	ordered to be filed until the time rates are set to go into effect December 1, 2007. Because an	
24	extension of the suspension period would result in the continuation of rates that Staff has foun

1	unjust and unreasonable, Staff respectfully requests that the effective date of rates not be	
2	extended.	
3	If the Commission were able to issue an order before the effective date with the briefing	
4	schedule requested by CRRWC, Staff does not object to CRRWC's briefing schedule. However,	
5	Staff does not support a further suspension of CRRWC existing rates.	
6	Staff supports November 5 <sup>th</sup> for opening briefs and November 13 <sup>th</sup> for reply briefs. As an	
7	alternative, Staff requests that there be one round of simultaneous briefs due November 9 <sup>th</sup> or	
8	November 13th. This alternative would allow CRRWC its requested time to review the	
9	transcript and also allow the Commission to issue a decision without a further suspension of	
10	CRRWC's existing rates.	
11	CONCLUSION	
12	For the foregoing reasons, Staff respectfully urges the Commission to deny CRRWC's	
13	motion to further suspend CRRWC's existing rates.
