III.

Integra has an interest in the subject matter of this proceeding. Integra is a competitive telecommunications service provider authorized to provide local exchange service in the State of Oregon. Integra offers intrastate telecommunications services within Oregon, including local exchange service and intrastate long distance service. Integra purchases unbundled network elements (UNEs) from Qwest Corporation (Qwest), pursuant to the parties' interconnection agreement, in order to provide those services.

On June 22, 2007, Qwest filed a petition in this docket requesting that the Commission approve additions to Qwest's non-impaired wire center list. Qwest's petition could impact the rates that Qwest offers its wholesale customers, such as Integra, if wire centers were added to the non-impaired list and certain products and services thus became unavailable to competitive providers at UNE rates in those wire centers. Changes in the rates Integra is charged for wholesale services that it purchases from Qwest could impact Integra's ability to offer the products and services it offers in Oregon. Integra therefore submits this Petition to Intervene because it is materially interested in, and will be substantially affected by, the Commission's resolution of the issues presented in this proceeding.

IV.

Integra expects to participate in the docket to contribute to the investigation its factual history and perspective as a wholesale customer/competitor of Qwest. Integra will address such issues as it deems relevant in this proceeding.

IV.

Integra has knowledge and expertise that will assist the Commission and the parties in addressing the issues presented in this proceeding.

V.

Integra's appearance and participation will not unreasonably broaden the issues, burden the record, or unreasonably delay this proceeding.

CONCLUSION

Integra's Petition to Intervene should be granted.
