9 Comes now staff of the Public Utility Commission of Oregon (staff) and replies to
10 Portland General Electric Company's (PGE) response in opposition to staff's Motion to Suspend
11 Schedule and Request for Prehearing Conference. PGE opposes staff's request but does state
12 that, if a short delay is allowed, the already-reserved March 11, 2008 date be retained for the
13 prehearing conference.

14 Staff supports this suggestion by PGE and requests the Administrative Law Judge (ALJ)
15 issue a Ruling setting a prehearing conference for March 11, 2008, or another available date that
16 same week. Staff will commit to informally circulating to the parties a new proposed schedule
17 for this docket no later than March 10, 2008 (sooner if possible).
