1. My name is Sheila Cox. I am a Legal Assistant in the Legal Department of Portland General Electric (“PGE”).
2. I electronically filed reply comments on November 9, 2007 at 2:10 pm. on behalf of PGE in this matter. (See Exhibit A – PGE Email Properties of LC 43 PGE’s Reply Comments with transfer time of 2:10:32 pm)
3. I telephoned Becky Beier, PUC administrative staff, for confirmation of filing at 3:45 pm that same day. Becky stated that she did not receive the filing, requesting me to resend to herself and the filing center. 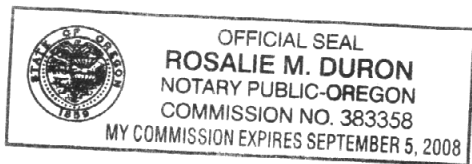


