9               Comes now staff of the Public Utility Commission of Oregon (staff) and requests the  
10 Administrative Law Judge (ALJ) issue a Ruling modifying the schedule in the present docket in  
11 the following respects: suspending the present schedule, specifically the two remaining events:  
12 (1) staff's submission of its public meeting memorandum, recommendation and draft order,  
13 currently now past due [due on February 27, 2008] and (2) the special public meeting now  
14 scheduled for March 11, 2008.

15               The reason for this request is that staff finds it will need an extended, but still  
16 undetermined, amount of time to complete its review of Portland General Electric Company's  
17 (PGE) Integrated Resource Plan (IRP). Due to this circumstance, staff requests the present  
18 schedule be suspended and the ALJ schedule another prehearing conference as soon as  
19 reasonably convenient.
