Dear Judge Power:


The parties met today as scheduled to continue their settlement discussions. While not all matters are settled with certainty, the parties believe the positive state of the discussions warrant two changes to the current schedule.

First, no party desires an evidentiary hearing. As such, the parties ask that you cancel the hearing now scheduled for October 31, 2007.

Second, the parties ask that the date for reply testimony, now set for October 19, 2007, be moved to October 31, 2007, to allow additional time for continued settlement discussions.

While the parties remain hopeful for an all-party settlement on all issues, as stated, that is not yet the case. Accordingly, the parties ask that the rest of the schedule, calling for briefing and oral argument, remain unchanged.


