14	ICNU does not oppose the new schedule based upon the understanding that the new			
15	schedule will not delay the October 15, 2010 anticipated Commission order date. ICNU			
16	requests that any new schedule allow the Commission sufficient time to issue an order by			
17	October 15, 2010.			
18	Staff's request arises from the need for additional time to review and analyze the			
19	complex testimony submitted by Idaho Power and PGE. Staff's requested short delay			
20	will allow time and opportunity to provide a more thorough review of the companies'			
21	filed testimony and to incorporate the most recent information provided by the			
22	companies' in their respective responses to the parties' data requests.			
23	Staff emphasizes that the following proposed amended schedule will still allow			
24	for a Commission Order to be issued on October 15, 2010, consistent with the original			
25	schedule.
