

**PACIFICORP'S STIPULATED MOTION TO
EXTEND TIME FOR FILING
SUPPLEMENTAL TESTIMONY BY ONE
DAY
(Expedited Treatment Requested)**

On July 6, 2009, Administrative Law Judge ("ALJ") Allan Arlow modified the schedule in this proceeding to provide that the companies file supplemental testimony on July 23, 2009. Since that time, PacifiCorp, Staff, the Citizens' Utility Board ("CUB"), and the Industrial Customers of Northwest Utilities ("ICNU") have been working to come to settlement on various issues in this docket. These parties are currently in the process of finalizing a partial settlement. In the event that the parties reach a partial settlement, PacifiCorp will not need to file supplemental testimony on certain issues that are the subject of settlement.

PacifiCorp requests that the Commission extend the time for PacifiCorp's filing of supplemental testimony by one day—to July 24, 2009. Staff, CUB, and ICNU do not oppose this request. This one-day delay will facilitate finalization of a partial settlement and a reduction in the scope of its supplemental testimony.


PacifiCorp respectfully requests that the Commission approve this extension of the time for PacifiCorp filing supplemental testimony by one day to July 24, 2009. The rest of
