**Re: UM 1368 Proposed Schedule**

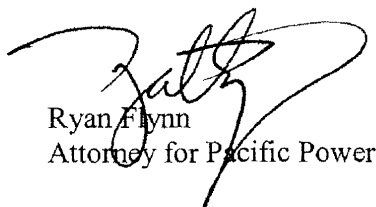
Judge Kirkpatrick:

On March 4, 2008, PacifiCorp filed a request to open the above-referenced docket and begin the solicitation process for an independent evaluator relating to PacifiCorp's request for approval of a 2008R-1 solicitation process for new renewable resources ("2008R-1 RFP"). On April 28, 2008, PacifiCorp filed a draft request for proposal. The Industrial Customers of Northwest Utilities, the Citizens' Utility Board, and the Renewable Northwest Project intervened in this proceeding (collectively, the "Intervening Parties").

In lieu of a prehearing conference, PacifiCorp, Staff, and the Intervening Parties have worked together to agree on a proposed schedule in this proceeding. Accordingly, enclosed is a proposed schedule as agreed to by all of the parties in UM 1368.
