**PACIFICORP'S STIPULATED MOTION  
TO AMEND PROCEDURAL SCHEDULE  
IN DOCKET UE 199**

On July 28, 2008, PacifiCorp d/b/a Pacific Power ("PacifiCorp" or the "Company") filed its rebuttal and Transition Adjustment Mechanism ("TAM") update in Docket UE 199. To allow additional time for the parties to review and investigate the Company's TAM update, and to permit the parties to convene additional settlement discussions, PacifiCorp respectfully requests that the Commission amend the procedural schedule in UE 199 as set forth in this motion. Because one of the parties' proposals is to consolidate certain UE 199 issues for hearing into UE 200, PacifiCorp is also filing this motion in Docket UE 200.

Currently the schedule in UE 199 provides for Staff/Intervenor Surrebuttal Testimony to be filed today, August 8, 2008, along with cross-examination statements, and a hearing (with live Sursurrebuttal) on August 15, 2008. The schedule then sets forth briefing dates, with a target date for a Commission decision of October 24, 2008. The schedule is designed to produce final net power costs for the Company prior to the date of

1 the November 15, 2008 direct access shopping window, for purposes of calculating the  
2 Transition Adjustment for 2009.

3 PacifiCorp proposes, and Staff, Industrial Customers of Northwest Utilities,  
4 Citizens' Utility Board, and Sempra Energy Solutions LLC support, the following revised  
5 schedule:

7	Staff/Intervenor Surrebuttal-UE 200 issues	August 13, 2008
8	Company Sur-surrebuttal-UE 200 issues	August 22, 2008
9	Staff/Intervenor Surrebuttal	September 4, 2008, at noon (with workpapers)
10	Company Sursurrebuttal	September 15, 2008 at noon (with workpapers)
11	Hearing	September 19, 2008
12	Briefing dates	To be determined at hearing

14 In conjunction with this proposed schedule, the parties have reached several other  
15 agreements:

- 16 • The parties hope to be able to narrow the issues sufficiently so that the  
17 Commission may set a reasonable briefing schedule and still issue its final  
18 order in this case in time for calculation of the Transition Adjustment  
19 associated with the November 15, 2008 direct access shopping window.  
20 However, the Company agrees not to use the direct access effective date  
21 as an argument against allowing an appropriate amount of time for briefing  
22 and a Commission decision in this case. In relation to the new schedule,  
23 the Company agrees that, if necessary, it will request a waiver of OAR 860-  
24 038-0275 (setting the direct access window on or about November 15 of  
25 each year) to change the date of the direct access window to allow  
26 sufficient time for completion of this docket.

- 1 • The parties propose to consolidate the UE 199 issues related to UE 200  
2 into the UE 200 docket and under the UE 200 hearing schedule. This  
3 includes Staff's issues related to the capacity factors of the Rolling Hills and  
4 Glenrock wind facilities, and the potential inclusion of two new wind  
5 resources in the July TAM update and the Renewable Adjustment Clause.  
6 This does not include issues related to wind integration charges, which will  
7 remain under the UE 199 schedule. Under the current UE 199 schedule,  
8 Staff and intervenor testimony on these issues is due August 8, 2008. Staff  
9 and intervenors now agree to file this testimony no later than August 13,  
10 2008. The Company will respond with sur-surrebuttal testimony on these  
11 issues, and the issues raised in Staff's previously filed surrebuttal on the  
12 Glenrock project, concurrently with the Company's UE 200 rebuttal, now  
13 due on August 22, 2008.
- 14 • The parties agree to a settlement conference on the previous hearing date  
15 of August 15, 2008.
- 16 • Staff and intervenors agree to use best efforts, taking into consideration the  
17 volume and complexity of the data requests received, to respond to  
18 discovery on their surrebuttal testimony within 4 business days, further  
19 taking into consideration that the intervening UE 200 hearing may mean  
20 that 5 business days are required for some of the responses. PacifiCorp  
21 agrees to use best efforts, taking into consideration the volume and  
22 complexity of the data requests received, to respond to discovery on its  
23 sursurrebuttal received by noon on Tuesday, September 16, by Thursday,  
24 September 18, 2008.

1           On behalf of all of the parties, PacifiCorp respectfully requests that the  
2 Commission approve this revised schedule, along with the related procedural agreements,  
3 to promote the effective resolution of the issues in this case and in Docket UE 200.


