Edge Wireless offered a variety of valuable calling plans to consumers that when taking into account all the features, including the inherent mobile nature of wireless service, are comparable to those offered by the ILEC. For example, LocalEdge and LocalEdge Carryover calling plans had a variety of included minutes, which began at 800 minutes. Edge Wireless also offered an UnlimitEdge calling plan with unlimited local calling that included unlimited minutes for calls made anywhere on the Edge Wireless network (Edge Wireless' network was located in portions of Oregon, Northern California, Idaho and Western Wyoming) to anywhere in the United States; therefore, the calling area was generally wider than the ILEC. LocalEdge and UnlimitEdge calling plans also included long distance calls to anywhere in the United States at no charge. In addition, Edge Wireless offered the WesternEdge, WesternEdge Carryover, NationalEdge and NationalEdge Carryover calling plans which included at no extra charge calls to anywhere in the United States, and these calling plans had larger areas that customers could place calls without incurring roaming charges. Finally, all Edge Wireless calling plans included 911 emergency calls and 611 calls to customer care at no charge, toll-free 511 road reports

to the Oregon Department of Transportation, and toll-free 711 calls to TRS/TTY operators. Exhibit 1.1.B. contains the brochures for the above referenced calling plans.

Moving forward AT&T Mobility rate plans are available to new customers in the Edge ETC area; Edge calling plans are generally no longer available to new customers.

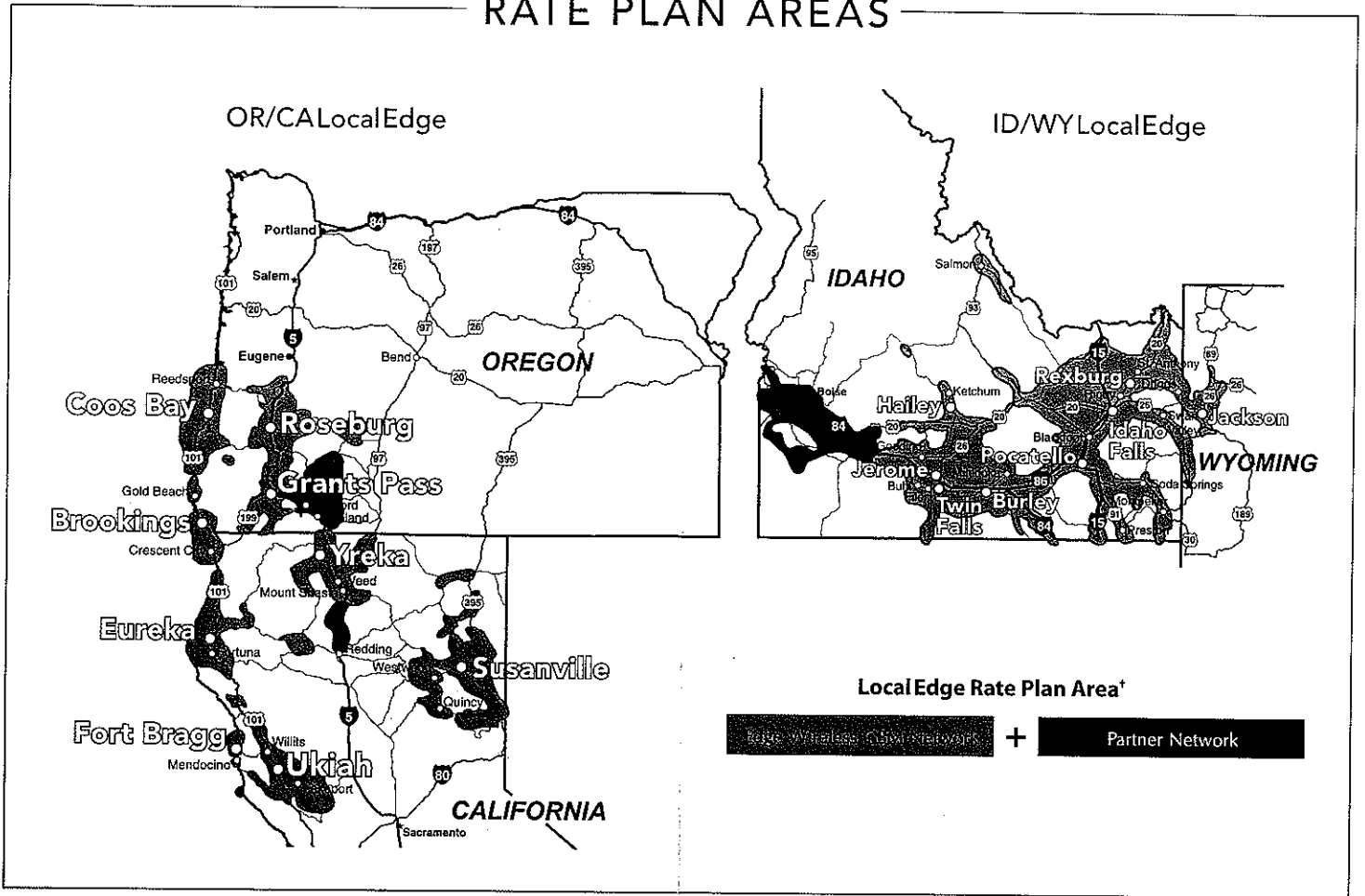

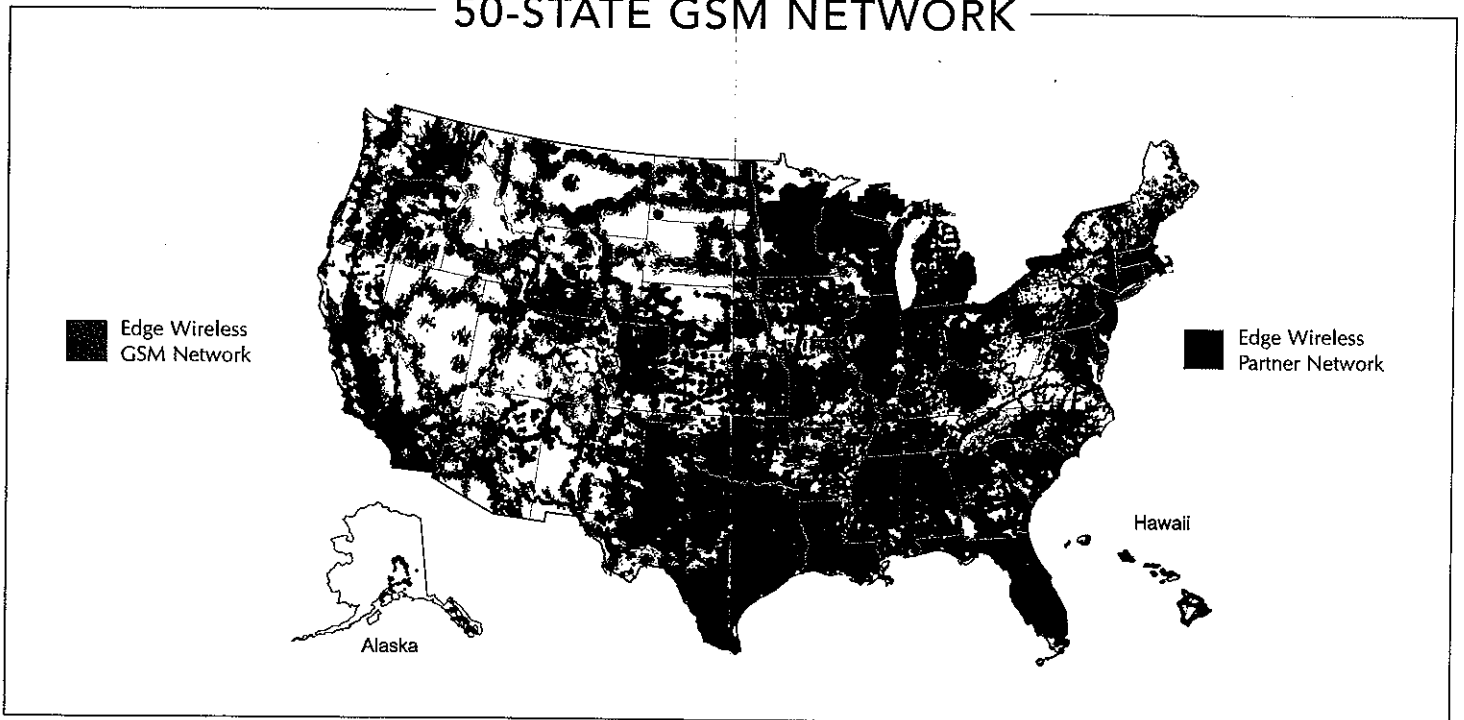
