COMES NOW, Defendant, Crooked River Ranch Water Company moves this Court for an Order extending the time period for response to the Staff's Motion for Summary Disposition.

This motion is made in good faith, not for the purposes of delay.

July 1, 2008 Staff filed their Motion for Summary Disposition. CRRWC has until July 15, 2008 to tender a response to that motion. On July 7, 2008, CRRWC filed a Petition for Alternative Writ of Mandamus and Order Allowing Writ of Mandamus in Jefferson County Circuit Case No. 08CV-0055, copies of which were served on the Public Utility Commission. The mandamus action in Jefferson County Circuit Court would be dispositive of Staff's Complaint for Civil Penalties and Motion for Summary Disposition in PUC Docket Number UM 1381 if CRRWC prevails.

1 In the interest of judicial economy CRRWC requests an extension time to respond to Staff's
2 Motion for Summary Disposition until 15 days after the Jefferson County Circuit Court has made
3 a final ruling on the Petition for Mandamus. CRRWC seeks to avoid devoting company resources
4 to litigation of the Motion for Summary Disposition until such time as it is determined whether that
5 litigation will be necessary.
