Dear Judge Wallace:

Thank you for attending the first part of the UM 1401 workshop on January 26, 2009. After you left, the UM 1401 parties discussed the best way to proceed in the docket in light of your statement that an order in Docket No. AR 521 would issue in the near future.

The parties agreed, subject to your approval, that it is appropriate to hold in abeyance any further proceedings related to that part of UM 1401 that concerns creating agreements and standards related to the interconnection of generators with a nameplate rating of between 10 MW and up to and including 20 MW. A Commission order in AR 521 would be the trigger for re-commencing, perhaps as a “Phase II,” that part of the UM 1401 related to such sized generator interconnection.

The UM 1401 parties further agreed that it is appropriate to continue to proceed under the present schedule to create standards and agreements related to the interconnection of generators with a nameplate rating over 20 MW.

Please advise in a ruling or other appropriate notice whether you find this proposal acceptable.
