On March 4, 2009, Portland General Electric, PacifiCorp and Idaho Power will file draft procedures and agreements for interconnection of PURPA Qualifying Facilities larger than 10 MW based on the utilities' FERC-approved documents. The filings will include redline versions of the FERC-approved documents showing modifications the utilities believe are necessary to make them fit within Oregon's regulatory scheme, as well as an explanation of all changes.

At this workshop, the utilities will present their planned modifications, get initial reactions and answer questions. Parties also may wish to discuss additional issues.

A call-in option will be available. Call-in information will be provided at a later date. Please advise if you plan to participate by phone. Thank you.


