Pursuant to ORS 756.568, CenturyLink moves the Commission for an Order to amend Order No. 09-168, entered May 7, 2009, and Order No. 11-137, entered April 26, 2011 which approved three Amendments to an Interconnection Agreement to correctly identify Quantum Communications, LLC, and not Quantumshift Communications, Inc. as the competitive carrier subject to the three filed Amendments. CenturyLink misidentified the applicable ARB docket when filing the Amendments. The three Amendments were inadvertently filed in Docket ARB 870, and should have been filed in Docket ARB 451.

CenturyLink asks the Commission make the three Amendments effective nunc pro tunc.
