Dear Judge Hardie:

Pursuant to ordering paragraph 2 in Order No. 12-159, issued on May 8, 2012, Idaho Power is required to provide to the Commission detailed information on the cost of serving Oregon customers during different time periods within the year. This filing is due within 60 days of the issuance of Order No. 12-159, or July 8, 2012.

The information that the Commission has requested is not information that Idaho Power currently possesses. Therefore, to comply with the Commission's directive, the Company has undertaken extensive analysis to develop the requested cost-of-service information. While the Company is making progress at developing this information, it will not be able to provide the detailed information to the Commission by the deadline set forth in Order No. 12-159. Therefore, the Company requests an extension of time to comply with ordering paragraph 2 of Order No. 12-159. The Company believes that an additional month will be sufficient to finalize and complete the analysis.

Based on communications with Commission Staff, the Company understands that they are supportive of this request.
