

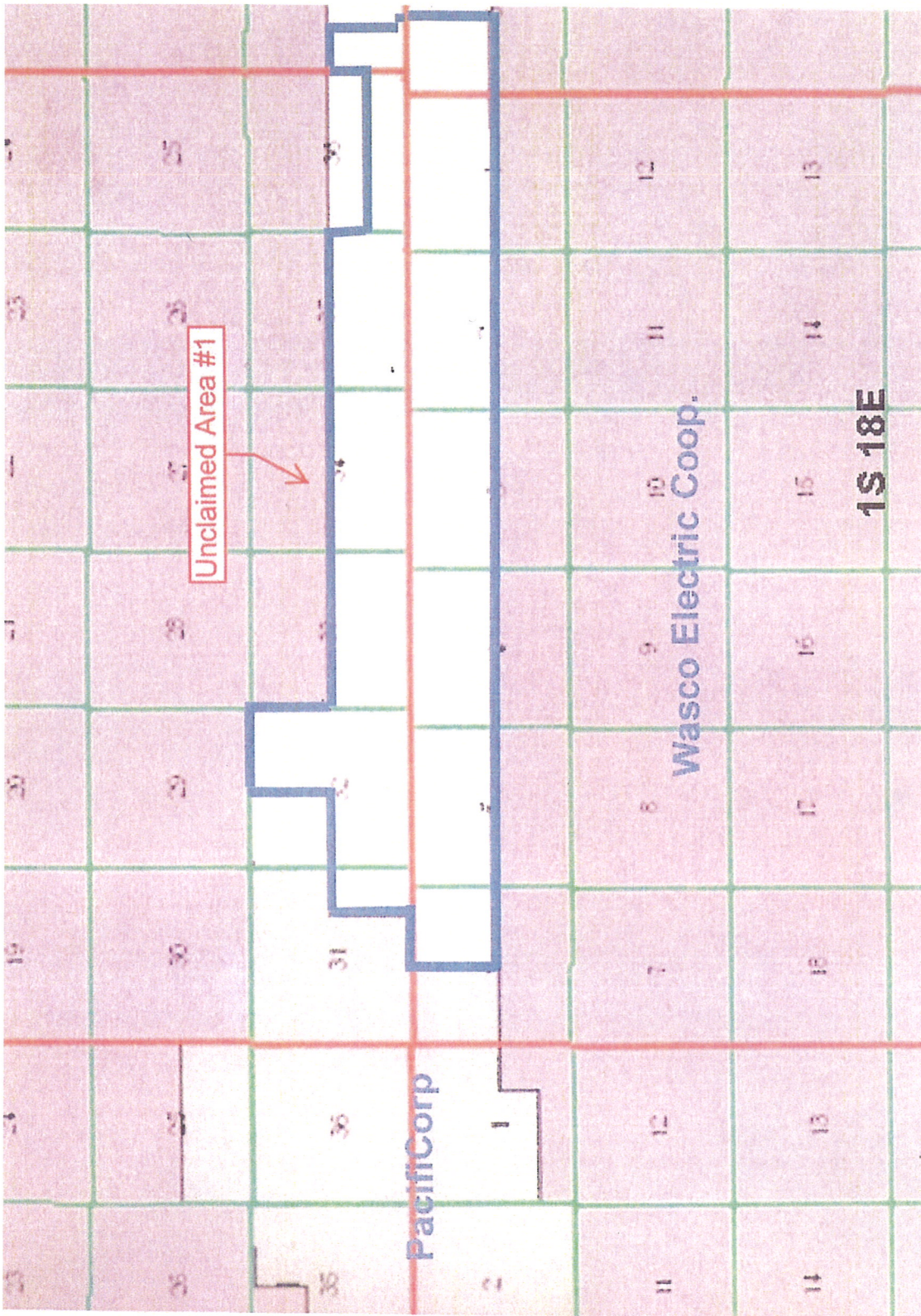

Beginning at the NE corner of the NW quarter of Section 32, T. 1N., R. 18E., W.M.; thence East along section line to the NE corner of Section 32, T. 1N. , R. 18E.; thence South to the West one-quarter corner of Section 33, T. 1N. , R. 18E.; thence East for three miles along the midsection line to the NW corner of the SW quarter of Section 36, T. 1N. , R. 18E.; thence South to the SW corner of the NW quarter of the SW quarter of Section 36, T. 1N. , R. 18E.; thence East for one mile to the SE corner of the NE quarter of the SE quarter of Section 36, T. 1N. , R. 18E.; thence North to the NE corner of the SE quarter of Section 36, T. 1N. , R. 18E.; thence East to the NE corner of the NW quarter of the SW quarter of Section 31, T. 1N., R. 19E.; thence South to the SE corner of the SW quarter of the SW quarter of Section 31, T. 1N. , R. 19E.; thence East 660' to the NE corner of the NW quarter of Section 6, T. 1S. , R. 19E.; thence South to the center of Section 6, T. 1S. , R. 19E.; thence West along midsection line to the center of Section 6, T. 1S. , R. 18E.; thence North to the North quarter corner of said Section 6; thence East to the South quarter corner of the SE one-quarter of Section 31, T. 1N. , R. 18E.; thence North to the North quarter corner of the SE quarter of said Section 31; thence East to the center of Section 32, T. 1N. , R. 18E.; thence North to the NE corner of the NW quarter of said section, the point of beginning.

Excepting there from the following describe parcel; that portion of the NW quarter of the NW quarter of Section 4, T. 1S. , R. 18E. on which PacifiCorp's distribution facilities interconnected to the Iberdrola Hay Canyon Substation are currently located.
