Beginning at the NE corner of the NW quarter of Section 32, T. 1N., R. 18E., W.M.; thence East along section line to the NE corner of Section 32, T. 1N., R. 18E.; thence South to the West one quarter corner of Section 33. T. 1N., R. 18E.; thence East for four and one-quarter miles along the midsection line to the NE corner of the NW quarter of Section 31, T. 1N., R. 19E.; thence East 660' to the NE corner of the NW quarter of section 6, T. 1S., R. 19E.; thence South to the center of Section 6, T. 1S., R. 18E.; thence North to the North quarter corner of said Section 6; thence East to the South quarter corner of the SE one quarter of Section 31, T. 1N., R. 18E.; thence North to the North quarter corner of the SE quarter of said Section 31; thence East to the center of Section 32, T. 1N., R. 18E.; thence North to the NE corner of the NW quarter of said section, the point of beginning.
