MOTION TO ADMIT TESTIMONY



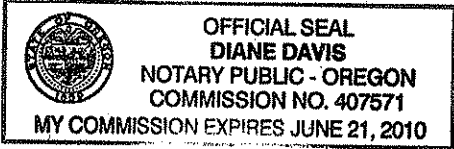
1 3. The pre-filed testimony referenced above, as well as my witness qualification statement,
