

I, Bob Jenks, being duly sworn on oath, depose and say:

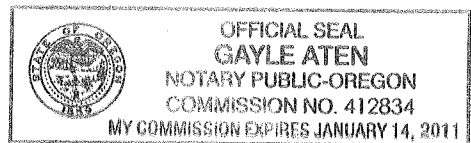
