MOTION FOR AMENDMENT TO SCHEDULE [EXPEDITED CONSIDERATION REQUESTED]

Portland General Electric Company ("PGE") requests that the Commission amend the schedule in this docket. Following a prehearing conference on April 21, 2009, the Administrative Law Judge set a schedule for the remainder of this docket. On July 10, 2009, Staff filed a motion, supported by all other parties, requesting that the date for Staff and Intervenor testimony be changed to July 22, 2009. That request was granted. Staff, the Oregon Department of Transportation, the Citizens' Utility Board, and ICNU have taken active roles in this docket and are referred to as the "active parties."

Because of accounting issues that need to be addressed, and ideas raised at settlement discussions to be explored, PGE, with the support of the other active parties in this docket, requests the dates for testimony and hearings in this matter be somewhat delayed. If a schedule cannot be agreed upon, PGE will file a request for a scheduling conference.
