The Industrial Customers of Northwest Utilities ("ICNU") does not identify any additional Pacific Power supplemental opening testimony that should be filed at this time. ICNU is still in the process of conducting discovery regarding PacifiCorp's filing, and ICNU will review the filings of Staff and other intervenors to determine if Pacific Power should supplement its opening testimony.

There currently is a process in Docket No. UE 199 (PacifiCorp's 2008 transition adjustment mechanism ("TAM") filing) that is addressing the scope of future TAM filings. It is possible that the parties to UE 199 may enter into a settlement that would defer the litigation of certain issues to Pacific Power's general rate case (Docket No. UE 210). If the parties enter into a settlement and defer certain issues, then Pacific Power should be required to file supplemental testimony on those issues.
