

2. KWUA is a nonprofit corporation comprised of nearly 20 public agencies, including irrigation districts and similar entities, and individuals and businesses located in and around the Klamath River Basin in Southern Oregon and Northern California. In addition, the members of districts comprising KWUA include individual irrigators on roughly 200,000 acres of land. Many KWUA members in Oregon, and the individual irrigators, purchase electricity from PacifiCorp under Schedule 41. Although the rates of many of KWUA's members are currently mitigated by operation of ORS 757.227, these rate-payers are transitioning to the full Schedule 41 rate.

3. PacifiCorp proposes to raise its Schedule 41 rate by at least 17.5%. KWUA, therefore, has a direct and substantial interest in this proceeding that will not be adequately represented by any other party.

4. KWUA's participation in this proceeding will assist the Commission in resolving the issues, and will not unreasonably broaden the issues, unduly burden the record, or delay the proceeding. It is in the public interest to allow KWUA to intervene in this proceeding.




