- 2. Fred Meyer is seeking intervention on its own behalf as a customer of PacifiCorp d/b/a Pacific Power. Petitioner is not seeking intervention in this matter as a member of a trade group or other organization.
- 3. Fred Meyer operates several grocery stores, convenience stores, warehouses, office, and manufacturing operations in the service territory of PacifiCorp. Petitioner has a substantial and diverse

interest in the outcome of this case that cannot be adequately represented by any other party.

allocation of the rate increase and the design of the new rates are just and reasonable.
