

I, Berit Kling, being first duly sworn on oath, depose and say:

1. My full name is Berit Kling. I am employed by PacifiCorp d/b/a Pacific Power as a Communications Specialist.

2. PacifiCorp filed with the Public Utility Commission ("Commission") of Oregon its Request for a General Rate Revision on April 2, 2009.

3. On May 4, 2009, PacifiCorp filed with Commission my Affidavit Regarding Notice of Proposed Rate Division as required under OAR 860-022-0017.

4. On May 11, 2009, Administrative Law Judges Sarah K. Wallace and Lisa D. Hardie issued a ruling requiring PacifiCorp to issue a correction in each of the newspapers of general circulation in which the original notice was published correcting the Commission's phone number and zip code.

5. Pursuant to the May 11, 2009 Ruling, PacifiCorp caused to be published a display advertisement announcing the correction on May 18, 2009 in the following newspapers of general circulation in the communities served by PacifiCorp: *The Daily Astorian, Albany Democrat Herald/Corvallis Gazette Times, Bend Bulletin, Coos Bay The World, Eugene Register-Guard, Klamath Falls Herald and News, Pendleton East Oregonian, Grants Pass Daily Courier, Medford Mail Tribune, The Oregonian, Roseberg News Review, and Salem Statesman Journal*. 


