As part of a stipulation of Commission Order 08-245, PGE developed a Residential Critical Peak Pricing (CPP) Pilot program, approved as Schedule 12. PGE filed Schedule 12 tariff sheets on September 17, 2009 in Advice 09-05, which became effective September 23, 2009.

Commission approval of PGE's request to defer revenues and expenses associated with the CPP pilot was received through Order 09-395 dated October 2, 2009.

On June 10, 2010, PGE withdrew its Residential Critical Peak Pricing Pilot. PGE has determined that the deferral is no longer required hereby withdraws its deferral application in docket UM-1427. We request that this docket be closed.
