

Portland General Electric Company (“PGE”) hereby moves for suspension of the procedural schedule in this docket. A settlement conference was recently held in this docket, and settlement of this docket was reached between PGE and all other parties: Staff of the Public Utility Commission of Oregon (“Staff”), the Citizens’ Utility Board of Oregon, and the Industrial Customers of Northwest Utilities (collectively, the “Parties”). The Parties are in the process of drafting a Stipulation and supporting Joint Brief to be submitted to the Commission containing the settlement terms. PGE, with the support of the other Parties, requests that the procedural schedule be suspended pending submission of the stipulation.


