

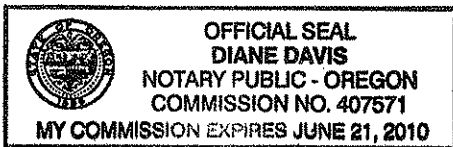
I, Judy Johnson, being duly sworn on oath, say:


1. I am the Program Manager, Rates and Tariffs, for the Public Utility Commission of Oregon (Commission).
