## To Judge Pines and all parties,

In view of the need to revise the schedule in this proceeding, TracFone has reevaluated its current priorities in light of the demands on its resources. TracFone has decided to ask the Commission to suspend the current schedule in this proceeding and to temporarily stay this case at this time. TracFone appreciates the efforts of Staff, CUB, and the other parties in cooperating on discovery matters and attempting to craft a new schedule. TracFone thinks, however, that its needs and the efforts of the Commission and the parties will be best served by suspending this proceeding at this time, effective immediately. This means, among other things, that the depositions scheduled for next week will not take place, TracFone will not respond to CUB's motion to compel, no further testimony will be filed, and the hearing will be canceled, until such matters are rescheduled. When TracFone is ready to resume, it will contact the other parties in an effort to resolve outstanding discovery issues and to agree on a new schedule for the remainder of the proceeding, before bringing any such issues to the ALJ in a prehearing conference. Once again, we appreciate your efforts in working with TracFone on this case and look forward to continuing proceedings in the not-too-distant future.

We are happy to go forward with the prehearing conference at 11 a.m., unless Judge Pines prefers to proceed in a different manner. Thank you for your attention to this matter.
