**TRACFONE WIRELESS,
INC.'S UNOPPOSED
MOTION TO MODIFY
PROCEDURAL SCHEDULE**

TracFone Wireless, Inc. (“TracFone”) respectfully moves the Commission to modify the procedural schedule in this docket. In particular, TracFone requests the Commission to extend the date by which parties may file testimony in response to TracFone’s testimony from July 20, 2010 until August 3, 2010. TracFone does not request any modifications to the remaining dates in the procedural schedule. TracFone has contacted Commission Staff and the intervenors regarding this motion. All parties have advised TracFone that they consent to this motion.

TracFone requests this modification to the procedural schedule so that all parties have sufficient time to file responses to TracFone’s testimony after receiving TracFone’s responses to outstanding Commission Staff’s data requests. Commission Staff issued a third set of data requests containing 40 requests on June 23, 2010, and issued a fourth set of data requests containing 17 requests on June 30, 2010. Given the large number of requests and the unavailability of key personnel, TracFone requested until July 16, 2010 to respond to Commission Staff’s third and fourth sets of data requests. Commission Staff agreed to this extension provided that a similar extension of time would apply to the date by which Staff and intervenors must file their response to TracFone’s testimony. Therefore, the revised due date for Staff and intervenors’ testimony would be August 3, 2010.

Based on the foregoing, TracFone requests the Commission to grant this motion and issue a revised procedural schedule setting the date for parties to file testimony in response to TracFone's testimony as August 3, 2010.
