**TRACFONE WIRELESS, INC.'S  
UNOPPOSED MOTION TO REVISE  
SCHEDULE**


8 TracFone Wireless, Inc. ("TracFone") respectfully moves the Commission to modify the  
9 schedule in this case only by changing the date by which TracFone must pre-file its reply  
10 testimony from April 5, 2011 to April 12, 2011. TracFone does not request any other change to  
11 the schedule. TracFone has conferred with counsel for Commission Staff, Citizens' Utility  
12 Board, and Oregon Office of Emergency Management, and none of those other parties objects to  
13 this motion.

14 TracFone makes this request so that the parties may continue their efforts to reach a  
15 settlement of the issues in this case. The parties held a settlement conference on March 29, 2011,  
16 and TracFone is in the process of preparing a settlement proposal for the other parties to review.  
17 It will be difficult for TracFone simultaneously to work on the settlement proposal and to prepare  
18 reply testimony. In addition, TracFone notes that the April 5, 2011 date for reply testimony was  
19 agreed to in connection with a proposed April 12, 2011 hearing date. Now that the hearing has  
20 been rescheduled for April 21, 2011, the other parties will not be prejudiced by TracFone's filing  
21 its reply testimony on April 12, 2011.
