MOTION TO WITHDRAW

INTRODUCTION

Pursuant to OAR 860-013-0031, PacifiCorp, d.b.a. Pacific Power (“PacifiCorp” or “Company”), hereby requests the Public Utility Commission of Oregon (“Commission”) to issue an order authorizing PacifiCorp to withdraw without prejudice its Application for Accounting Order Regarding Coal Stripping Costs (“Application”).


DISCUSSION

On September 3, 2009, the Company filed its Application, requesting the Commission to issue an order, effective January 1, 2010, authorizing the Company to record a regulatory asset associated with the costs for removal of overburden and waste materials at its affiliate coal mines. At that time, the Company was attempting to address net power cost issues associated with the Transition Adjustment Mechanism (“TAM”) proceeding (UE 207). Since that time, the parties in UE 207 have reached an all-party settlement which includes a commitment by PacifiCorp to request to withdraw this application without prejudice and an agreement by the other parties (Staff of the Public Utility Commission of Oregon, the Citizens’ Utility Board, the Industrial Customers of Northwest Utilities, and Sempra Energy

Solutions LLC) not to object to this withdrawal. The TAM settlement stipulation and accompanying joint testimony are being filed concurrently with this Motion.

For the reasons stated above, the Company respectfully requests that the Commission allow PacifiCorp to withdraw the Application without prejudice.


