- 1. Sierra Club, NEDC, Friends of Columbia Gorge and Columbia Riverkeeper (Intervenors) affirm and reiterate the desirability of including public meeting in Portland in the schedule for this docket to allow broader, more meaningful participation by PGE ratepayers and intervenors. Intervenors additionally request that they be given the opportunity to present and discuss their comments and concerns at the PUC Public Meeting, scheduled for May 25 in Salem.
- 2. This docket had generated substantial interest from a wide variety of organizations and PGE ratepayers in general. Because of this exceptional interest and because a substantial part of PGE's customer base resides in the greater Portland area, a public meeting in this forum would allow for significantly greater access to and participation in this matter. The vast majority of the intervenors in this docket are likewise based in Portland. Moreover, PGE does not object to such a meeting and other intervenors, such as the Ecumenical Ministries of Oregon, the City of Portland and the Northwest Energy Coalition have either requested or concurred in the desirability of such a meeting.

This venue affords commissioners and intervenors alike the chance to clarify and better understand comments and respond to any questions or issues that they raise.

Accordingly, Sierra Club, NEDC, Friends of Columbia Gorge and Columbia Riverkeeper respectfully request that a public meeting with the commissioners be held in Portland sometime between June 11 and July 9, most preferably on an evening between June 18 and July 1. Said parties further request that intervenor presentations be allowed during the scheduled meeting on May 25, 2010.
