Pursuant to OAR 860-013-0031, Portland General Electric Company (PGE) proposes to revise the remainder of the schedule established for this docket in Administrative Law Judge (ALJ) Pines' Prehearing Conference Memorandum dated December 3, 2009.

PGE proposes the following revised schedule:

April 9, 2010 - PGE files IRP

April 26, 2010 - PGE Presentation at Commission Public Meeting

May 14, 2010 - Intervenors' Comments Due

June 11, 2010 - PGE Reply Comments Due

July 9, 2010 - Staff Final Comments and Draft Proposed Order Due

July 30, 2010 - PGE/Intervenors' Reply to Comments Due

August 24, 2010 - Commission Public Meeting

On April 1, 2010, PGE circulated the proposed schedule to all parties in the docket. PGE did not receive any objections. However, the Northwest Energy Coalition (NWEC) requested that the schedule include an evening public meeting in Portland to give ratepayers an opportunity to comment. The City of Portland, Ecumenical Ministries of Oregon, Sierra Club, Northwest Environmental Defense Center, Friends of the Columbia Gorge and Columbia Riverkeeper concurred with the NWEC's request. Defense Center, Friends of the Columbia Gorge and Columbia Riverkeeper asked that the meeting be held n the evening sometime between June 11, 2010 and July 9, 2010, so that the public can express their views on PGE's 2009 IRP, its amendment, and the Intervenor and PGE comments submitted in the docket before Staff submits final comments and a draft proposed order. PGE neither objects nor supports the request for an additional public meeting.

The Sierra Club, Northwest Environmental Defense Center, Friends of the Columbia Gorge and Columbia Riverkeeper also asked that Intervenors be allowed to make a presentation at the May 25 Commission Public Meeting to present the concerns with PGE's 2009 IRP identified in Intervenors' comments. PGE has no objection to this request.

Accordingly, PGE respectfully requests that the ALJ approve the revised schedule and rule on the requests for an additional public meeting and for the opportunity for Intervenors to make a presentation at the May 25 Commission Public Meeting. PGE requests expedited treatment of this Motion.
